SECTION 2 - HAZARDS IDENTIFICATION

Classification : OSHA: Hazardous classification: Flammable liquid; Acute Health Hazard; Chronic Health Hazard.

Emergency Overview : Colourless liquid. Solvent odor.
Warning! Flammable liquid and vapor. May be harmful if inhaled. Inhalation may cause respiratory irritation and central nervous system depression. Could result in pulmonary edema (fluid accumulation). Causes skin and eye irritation. May be harmful or fatal if swallowed. May cause gastrointestinal discomfort. Aspiration can result in life-threatening lung injury. Contains material which can cause cancer.

POTENTIAL HEALTH EFFECTS:

Signs and symptoms of short-term (acute) exposure

Inhalation : Harmful by inhalation. Inhalation may cause respiratory irritation and central nervous system depression. Symptoms may include pain, headache, nausea, vomiting, dizziness, drowsiness and other central nervous system effects. Inhalation of extremely high concentrations could cause pulmonary edema (fluid accumulation). Symptoms of pulmonary edema (chest pain, shortness of breath) may be delayed.

Skin : May cause mild to moderate skin irritation.

Eyes : May cause moderate to severe irritation.

Ingestion : Ingestion may irritate digestive tract and cause nausea, vomiting and diarrhea. Aspiration into the lungs during swallowing or subsequent vomiting may cause chemical pneumonitis, which can be fatal.

: Prolonged or repeated contact may cause drying, cracking and defatting of the skin.

SECTION 4 - FIRST AID MEASURES

- Inhalation** : Immediately remove person to fresh air. If breathing has stopped, give artificial respiration. If breathing is difficult, give oxygen by qualified medical personnel only. Get medical attention.
- Skin contact** : Remove/Take off immediately all contaminated clothing. Wash off immediately with plenty of water for at least 15 minutes. Get medical attention. Wash contaminated clothing before re-use.

SECTION 5 - FIRE FIGHTING MEASURES

- Fire hazards/conditions of flammability** : Flammable liquid and vapor. This material may be ignited by heat, sparks and direct flame. Material will float on water and can be re-ignited at the water's surface. Closed containers may rupture if exposed to excess heat or flame due to a build-up of internal pressure.
- Flammability classification (OSHA 29 CFR 1910.1200)** : Flammable Liquid Class 1C.
- Oxidizing properties** : None known.

- Special fire-fighting procedures/equipment** : Firefighters should wear proper protective equipment and self contained breathing apparatus with full face piece operated in positive pressure mode. Move containers from fire area if safe to do so. Water spray may be useful in cooling equipment exposed to heat and flame.

SECTION 6 - ACCIDENTAL RELEASE MEASURES

- Personal precautions** : All persons dealing with clean-up should wear the appropriate protective equipment including self-contained breathing apparatus. Keep all other personnel upwind and away from the spill/release. Restrict access to area until completion of clean-up.
- Environmental precautions** : Ensure spilled product does not enter drains, sewers, waterways, or confined spaces. For large spills, dike the area to prevent spreading.
- Spill response/cleanup** : Ventilate area of release. Remove all sources of ignition. Use only non-sparking tools and equipment in the clean-up process. Contain and absorb spilled liquid with non-combustible, inert absorbent material (e.g. sand), then place absorbent material into a container for later disposal (see Section 13). Notify the appropriate authorities as required.
- Prohibited materials** : Do not use combustible absorbents, such as sawdust.

SECTION 7 - HANDLING AND STORAGE

- Safe Handling procedures** : Use in a well ventilated area. Wear suitable protective equipment during handling. Do not ingest. Avoid breathing vapour or mist. Avoid contact with skin, eyes and clothing. Keep away from heat, sparks, and open flames. Use proper bonding and grounding techniques when transferring liquid. Avoid contact with incompatible materials. Wash thoroughly after handling.
- Storage requirements** : Store in a cool, dry, well-ventilated area. Store away from incompatibles and out of direct sunlight. Storage area should be clearly identified, clear of obstruction and accessible only to trained and authorized personnel. Inspect periodically for damage or leaks. No smoking in the area.
